 - Chief Amezaga noted the term of the current IGA ends June 30, 2023. Should the board wish to continue the IGA, Board approval required by both the NSFD and RRMFD boards
 - Motion for the extension of the Nogales Suburban and Rio Rico Intergovernmental Agreement to be extended to June 30, 2024 made by Dora Madrid, second by Armando Castillo
 - Motion passed unanimously by verbal vote
 - c. Discussion and possible action re: Presentation of the 2023-2024 Budget proposal and approval for publication.
 - Ana Holman presented the 2023-2024 Budget Proposal noting the Assessed Value tax at the 3.5% rate, the FDAT tax and interest income would result in \$396,567 in revenue. Expenses \$396,567, including personnel expense (\$325,799 85% of budget), administration expense, operational expense and lease expense
 - Same tax rate of 3.5% being proposed for RRMFD as well
 - Motion to accept the approval for publication of the Budget Proposal for 2023-2024 made by Dora Madrid, second by Armando Castillo
 - Motion passed unanimously by verbal vote
