  - New report has been established for the EMT/Fire Academy expenses
  - RRMFD property assessment increased by 6.25%; at current tax rate of 3.27% would increase tax revenue by \$171,240
  - NSFD property assessment increased by 1.47%; at current rate of 3.375% would increase tax revenue by \$5,262
  - Ana Holman clarified House Bill ARS 48-807(F) regarding the ceiling of the tax rate and also the decrease in tax rate for commercial property
  - Bond Sale is tomorrow, February 23, 2023. Pricing and update regarding insurance for rate reviewed
