NOGALES SUBURBAN FIRE DISTRICT HAS ENTERED AN INTERGOVERNMENTAL AGREEMENT WITH RIO RICO MEDICAL AND FIRE DISTRICT TO PROVIDE OPERATIONS AND MANAGEMENT SERVICES.

### **MEETING MINUTES**

The Fire Board of the Nogales Suburban Fire District met in regular session on March 16, 2023 at 5:00 p.m. The meeting was held at Nogales Suburban Fire District station #1, 558 Highway 82, Nogales, AZ.

- 1. CALL MEETING TO ORDER
  - Meeting is being recorded
  - Meeting called to order by Armando Castillo at 5:00 p.m.
- 2. PLEDGE OF ALLEGIANCE
- 3. ROLL CALL OF BOARD MEMBERS
  - Present: Armando Castillo and David Valenzuela. Dora Madrid arrived at 5:15 p.m.
- 4. CALL TO THE PUBLIC
  - a. Michael Carlson, 40 year retired consumer banker of which a large part of career was in mortgage financing. As annexation project is discussed, would like to address a potential issue homeowners need to be aware of. If you move out of the Fire District your homeowners insurance may be implicated. Make sure as you think about annexation, you contact your insurance company for verification of coverage. Most mortgages have a clause within them that if you do not have mortgage and fire insurance, they can call your mortgage and you will be in default of the covenants. If you choose not to be part of the annexation, please take the time to check with your insurance company and mortgage company as you could potentially be in default.
    - Public member stated he received letter and has many questions regarding annexation and how it fits together. Hoping for a presentation regarding annexation for clarification.
  - b. Public Hearing re: Presentation of amendment of the Nogales Suburban Fire District's boundaries to annex certain properties within Santa Cruz County and adjacent to the boundaries of the Nogales Suburban Fire District that have been paying taxes and received the fire protection services but not included on the legal description of the Nogales Suburban Fire District boundaries pursuant to A.R.S. Section 48-262(H)
    - Louis Chaboya addressed attendees noting he was helping RRMFD and NSFD with the annexation issue. He noted NSFD was established in 1981 at which time everyone had to sign petitions and go through the legal process to become part of NSFD. As mentioned, everyone has been paying taxes and receiving services from NSFD. RRMFD entered into an Intergovernmental Agreement March of 2021 to manage and help with response and staffing issues with NSFD for a two year period. Fire Marshal Cluff was reviewing response areas and mapping areas and discovered an error within the mapping area. The issue was addressed with the county who determined the draft version years ago did not include all areas although homeowners were paying taxes and receiving services causing the need to be legally updated (annexed) to include all areas. Letters were sent to those property owners affected requesting signature on the petition to annex area to continue receiving services and insurance; taxes will not be raised; services will continue without change. To pass annexation, 50% plus 1 signature are required (in

person or by mail with signature notarized) to be presented to County Board of Supervisors for approval.

- i. Chairman will open the hearing.
  - Hearing opened at 5:17 p.m. by Armando Castillo
- ii. Chairman will call to all present for those who wish to comment on the Amendment of the Nogales Suburban Fire District's boundaries as described in 4 b. and each person desiring to speak will be provided 3 minutes.
  - Public verified one owner of multiple properties only needs to sign one time
  - Areas outside of current boundaries and area being annexed are not covered.
  - Chief Amezaga noted the goal now is to take care of homes/residents that are currently paying taxes. County had a draft version, not the adopted version of the mapping, so those areas need to be annexed; second goal is to bring other outlying areas not annexed into district at the current tax rates.
  - Public questioned if annexing would help with the current fire department budget and if the fire department has been receiving the monies from those currently paying
  - Chief Amezaga noted taxes come in from homes and businesses; tax on vacant land
    is minimal, annexing properties have already been paying taxes, properties outside of
    boundaries would received a larger fire bill if department is utilized as they are not
    paying taxes for services.
  - Public verified arrangement between NSFD and RRMFD does not play into this.
     This is NSFD correcting the map. Should NSFD and RRMFD Boards decide to Merge/consolidate, it will then involve RRMFD
  - Public questioned time element in finalizing. Louis Chaboya will notify/contact those
    individuals not in attendance who didn't sign a petition as a courtesy; however, once
    he has all required documentation, he will submit to the Board of Supervisors for
    processing and approval
  - Public questioned the need for their signatures as one person/business owns 57
    properties and could easily meet the requirement. Louie Chaboya clarified it would be
    19 signatures of property owners
  - Michael Carlson summarized if 19 people sign, service continues as it always has with no difference in the tax rate. If 19 people don't sign, you will no longer pay taxes, you will no longer have fire service and then you may have the implication with your insurance company and potentially your mortgage company.
  - Ana Holman noted if this shouldn't pass, you may request up to three years of your paid taxes from the county.
  - Should it not be passed, you will still receive fire service; however, you will be billed for the services.
  - Basically, this is to finish up what wasn't completed back in 1980 and continue with same service and make it legal.
- iii. Chairman will close the hearing.
  - Hearing closed to the public
  - 10 minute recess taken for the collection of signatures from the property owners in attendance.
  - Meeting resumed at 5:48 p.m.
