The Fire Board of the Rio Rico Medical and Fire District (RRMFD) met in regular session on Wednesday, August 28, 2024 at 5:30 p.m. The meeting was held at Rio Rico Medical and Fire District administrative office, 822 Pendleton Drive, Rio Rico, AZ.

#### 1. CALL MEETING TO ORDER

### 6. REPORTS AND CORRESPONDENCE:

- a. Correspondence
  - Crews answered a cardiac arrest call of a patient with underlying medical conditions who
    unfortunately passed during the call. The patient was the brother of a NFD firefighter and the
    family members expressed their appreciation for RRMFD firefighter Adriane Demotica who
    went above and beyond by asking the family if they could join him in prayer which was very
    well received and gave them a sense of peace.
- b. Badge Pinning
  - Chief Amezaga noted his vision for RRMFD with community involvement, participation, development of District personnel, implementation of changes and to align those values, chose to promote BC Renteria to Deputy Chief. Pinned by his mother and wife.
  - DC Renteria thanked the Chief, Board, admin staff and crews, pillar of the department. Appreciates being part of the team, the community feel and proud to be back home

- Frank Bejarano stated September is suicide awareness month. Mariposa will be doing public public service announcements, information throughout the month; mental health awareness for adults, pediatrics, veterans. If you know someone who is in need, say something-if you don't talk about it, it suppresses; if you talk about it, it normalizes. Let them know you care. Chief Amezaga noted some personnel will be attending trainings for mental health keep personnel mentally well, physically well and financially well.
- Hank Thysell commented he had been in Ohio for a submarine convention and stopped to see one of his Navy buddies who was honored as the longest serving firefighter and has two sons in the fire service. Chief Amezaga had given him challenge coins from RRMFD to present and those who received them were very appreciative.

# f. Financial Report

- i. Presentation of Financial Reports up to July 2024
  - Report presented by Ana Holman. Copy of report on file.
  - July is the first month of the new fiscal year and was the highest month of revenue-Collecting \$280,000
  - Only two candidates for the Board seats therefore, there will be no election, Henry Thysell and Dora Urias have been appointed. NSFD
  - GOHS awarded RRMFD a grant in the amount of \$11,799 for car seats
  - FEMA awarded RRMFD a grant in the amount of \$999,063 with a 5% match by the District for the purchase of a fire truck. Award will require an additional audit due to amount.
  - District has been asked to become a member of the Pima County Fire Chief's Association
  - Financial Audit: walkthrough performed August 9<sup>th</sup> with no issues and field work is scheduled for the week of September 23, 2024
  - Awarded the Mental Health Grant through Securis
  - Meeting with attorney for the Santa Cruz County who stated to expect contact via Zoom with the person running numbers within the next two weeks
  - Ana Holman has been researching types of investments for the money invested within the county and where it can be invested. State treasurer told Ana about LGIP-Local Government Investment Pool which consists of 82 cities/towns; 48 special taxing districts and 11 counties. RRMFD has two accounts not tied to taxes, Capital Improvement and the Bond account and also our Chase account which has the contingency funds and excess funds including bond money. To join, a Resolution from the Board is required. Return investment depends on where you place the money currently 5% for two months cds. Suggested a committee be formed to review options, liquidity issues and overall risks involved.

- b. Discussion, review and update re: River Road Annexation of certain properties within Santa Cruz County and adjacent to the southeastern boundaries of the RRMFD
  - i. This is a continuation of previous discussion related to the River Road Annexation of certain properties within Santa Cruz County and adjacent to the southeastern boundaries of the RRMFD
    - Chief Amezaga updated Board members who were not in attendance at the public noting there was good attendance, had good questions and concerns noting they were unaware they were not within a fire district and thought they were within NSFD and from RRMFD was trying to poach them away from NSFD and defend NSFD stating they had always received good care. Additional concerns were address issues, taxes and would like time to speak with other members within the boundaries.
    - Louie Chaboya commented the Padilla needed to speak with other members of the LLC before signing; Sedgwick wanted to speak with other family members prior to signing and one resident was out of state and would be returning September 5<sup>th</sup>. Should have the required number of signatures by mid September
    - Michael Carlson suggested having a petition available for signature at Station 3
- c. Discussion, review and update re: Installation of the BlueStar Power System Industrial Outdoor Generator for Station 1
  - i. This is a continuation of previous discussion related to the installation of the BlueStar Power System Industrial Outdoor Generator for Station 1
    - Generator is installed; bollards installed, electrical installed, gas line installed however, the County is requesting testing and needs the ROC number. The person who installed the line is one of RRMFD's employees who will be taking the ROC test in two weeks. Giving him the opportunity to avoid having to undo and redo work by an ROC. Once propane is connected we can have the start up with Gen Tech.
