c. Fire Marshal Report

- NFIRS good through May, 2022
- Attended 4 trainings/webinars including Transgender Patient Sensitivity and Documentation. Frank
 Bejarano elaborated on sensitivity and identifiers; constant change and adaptation "how would you like
 to be addressed".
- No burn permits issued due to Stage II restrictions effective May 25, 2022. These restrictions were lifted Monday, June 27, 2022. Burn permits will be issued beginning July 1st, 2022. Ring and social media will be updated for issuance.
- 11 Plan Reviews/Inspections processed
- 14 Fire Calls including smoke from wildland fires and wildland
- Sandbags and sand available at Stations 2 and 3
- Observance noted motor homes throughout the District on lots allowed during construction only. Also noted lack of addresses on houses
- Tubac will be having fireworks. Brad Beach noted Rio Rico High School is looking at possibly having fireworks next year

d. Fire Board Member Report

Michael Carlson attended recruit Cut N Crunch. Commended Antonio Sanchez and Chris Cruz who were
very involved with the training of the recruits as well as Nick Quiroga and Malki Higuera – all fantastic
with group; Brad Beach saw water training yesterday-hats off to Frank Granados; RRMFD is a constant
force for the academy (minimal aid from other agencies)

e. Financial Report

- i. Presentation of Financial Reports up to May 31, 2022
 - Financial reports presented by Ana Holman
 - Collection as of June 29,2022 reached the \$2 million mark- 3rd year in a row
 - Received \$38,000 from Proposition 207 today
 - With operations moving to Image Trend, looking at their billing software as well. Currently waiting
 for operations conversion for integration with billing (cost within current range). Michael Carlson
 questioned possible downtime, affect on RRMFD and possible penalty to provider.
 - As previously discussed Workers Compensation insurance has increased along with the \$65,000 assessment; \$20 million assigned to workers compensation (through government) however, working on utilization of funds (funding until depleted, approximately 4-5 years); with calculation RRMFD should receive approximately \$43,000
 - AFCA/AFDA conference being held July 12th-14th in Glendale, Az. Attendees will be Chief Amezaga, Ana Holman, Jennifer Rayon, Brad Beach and Frank Bejarano
- f. November 2022 General Election Timeline update.
 - Three Board of Directors seats up for election, Brad Beach, Frank Bejarano and Michael Carlson posting 7-1-22 and 7-8-22 in Nogales International. NSFD has one seat up for election Armando Castillo. Has already submitted packet. Candidate deadline is July 11, 2022

7. OLD BUSINESS

- a. Discussion, update and possible action re: Nogales City Annexation
 - i. This is a continuation of previous discussion related to the Nogales City Annexation and RRMFD committee

 Michael Carlson noted Nogales hasn't been pursuing; however, RRMFD should continually keep annexation process in the present. Consensus of Board is that annexation hinges on the upcoming election. Frank Bejarano suggested we utilize a billboard (will need legal verification).

 - Motion to increase Chief Amezaga's salary to \$135,000 annually effective April 24, 2022. Doing this retroactively for the last three years is against every grain in my body. The Board has agreed that next year they will start working on Chief Amezaga's performance appraisal starting in February so this action can be done in our monthly meeting in March so that we are not doing things retroactively rather than a little bit more proactively. We'll ask Eva, our secretary, to make sure that she prods us to make sure it goes on the agenda and we'll ask Chief Amezaga to be equally aware of the timing so that he can start working on his self-appraisal in February so that we can do this in a more timely and appropriate fashion, made by Michael Carlson, second by Frank Bejarano.

 - Ana Holman noted the FDAT tax amount presented last month was reduced by the county by \$4,000

- f. Discussion and possible action re: Approval of Securis Insurance Pool, Inc. Assessment fee for policy year 2021-2022 in the amount of \$65,445.00
 - Ana Holman noted due to COVID, the insurance pool had a deficit for 2021-2022. Some of
 monies received (through above referenced funding) will be used for partial funding; subsidy
 will go toward contributions for 22-23. Quote for 2021-2022 was \$102,000, actual is \$167,000.
 RRMFD committed for 3 years and knew this was a risk when entering into contract.
 - Motion to approve the Securis Insurance Pool, Inc. Assessment fee for policy year 2021-2022 in the amount of \$65,445.00, understanding there will be some level of reimbursement for cost of fees in the future, made by Michael Carlson, second by Brad Beach
 - Dean Davis, Brad Beach and Michael Carlson voted in aye; Frank Bejarano voted nay
- g. Discussion and possible action re: Addition of "Battalion Chief of Training" classification to operational pay scale effective July 1, 2022
 - Chief Amezaga noted to open this position, Board needs to approve combining EMS Coordinator and Training Coordinator to new position Battalion Chief of Training \$65,645 annually.
 - Motion to approve addition of Battalion Chief of Training classification to the operational pay scale effective July 1, 2022 made by Frank Bejarano, second by Michael Carlson
 - Motion passed unanimously by verbal vote
- h. Discussion and possible action re: Sale of present UTV for market value and purchase of new UTV to include all associated fees, taxes, and equipment up to \$45,000.00
 - Current UTV should have never been fixed, continual problems. Current skid unit to be sold to
 offset current costs; turning down assignments due to continual problems. New unit is a fully
 enclosed cab; original unit RRMFD wanted has been sold.
 - Dean Davis questioned where new unit would be repaired if needed; restriction of who can operate the unit. Chief Amezaga noted repairs are done in Tucson and mandatory training would be required with bi-annual certification for personnel using the vehicle. Income from wildland equipment will be used to reimburse the Capital Reserve account until paid.
 - Motion to sell present UTV for market value and purchase of new UTV to include all associated fees, taxes and equipment up to \$45,000 made by Brad Beach, second by Frank Bejarano
 - Motion passed unanimously by verbal vote
