- Contract signed with Banner for Treat and Refer
- CHIPP Update Tangye was made aware of a particular family by Crew who transported the spouse to hospital and back to home. Crew discovered horrific living conditions; advised SO and APS; pets, flies, hoarding, stench. Male is the primary caregiver; female has early stage dementia; home health would not go there; Tangye worked with ALTCS and got a home health agency to come in and do a deep cleaning of resident; referral to neurologist, pulmonologist, cardiologist & home health. Treatment plan has been implemented. Asking for eyes to assist residents of the community.

Calle Carmelita – started in yard; spread to home; homeowner started fighting with water, RRMFD did knockdown to make sure nothing was burning or exposed and home did not smell of smoke

 - \$250,000 has been transferred to the operational reserve account
 - Bank of America account is still open waiting on Medicare auto payments to transfer to Chase
 - Wildland crew is back State holding back resources; updates coming out and will be reviewed by Chief Amezaga and Mark South
 - Journal entry from 2018 was for billing area, but not sure from what time period
 - Mike Vohland questioned why cable/TV was not paid for by the District. Currently the District pays half and the employees pay half
 - Audit has been completed; waiting on PSPRS information for possible November presentation to the Board

 - Motion to approve renewal of Property, Equipment, Auto, General Liability and Umbrella coverages with VFIS of Arizona for the annual amount up to \$59,043 including total premium and endorsement, to be paid quarterly, made by Michael Carlson, second by Dean Davis
 - Motion passed by votes from Dean Davis, Michael Carlson and Mike Vohland
 - Brad Beach did not vote as he was out of the meeting room
 - c. Discussion and possible action to amend adopted pension funding policy for the PSPRS system to include only Tier 1 and Tier 2 unfunded liabilities.

- Michael Carlson noted one of the items discussed last month was to bring the funding up to 90%. Michael Carlson and Chief Amezaga attended the annual PSPRS meeting in Phoenix and found Tier 1 and Tier 2 funds are specifically for ourselves, \$30,000, and the \$13,000 approved is a pool for everybody. Suggesting we maintain the 90% until Station 1 is completed, and then move to 100%, which is specifically for Tier 1 and Tier 2; adopt and resubmit to PSPRS.
- Michael Carlson motioned to amend last months approval so that we take same actions and focus solely on Tier 1 and Tier 2, second by Dean Davis
- Motion passed unanimously by verbal vote
- d. Discussion and possible action to form subcommittee to review and update RRMFD Fire Board Policy
 - Michael Carlson and Chief Amezaga have reviewed the policies and made recommendations. Chief Amezaga would like Board members to review before sending to Mr. Cope for finalization.
 - Michael Carlson felt it was to RRMFD's financial benefit for us to review and update Board and Financial Policies; have the board read and review and come back next month with approval to submit to Mr. Cope for finalization.
 - Mike Vohland would like to change the original wording to "Discussion and possible action to review and update RRMFD Fire Board Policy. No need for motion, Board should review and give feedback to Chief Amezaga and Michael Carlson
- e. Discussion and possible action to confirm date of RRMFD Financial Policy draft
 - Ana Holman emailed the RRMFD Financial Policy draft for review and feedback.
 - Chief Amezaga stated to the Board they are trying to do the work for the Board on the policies, it still needs to be approved by the Board. We will also be reviewing the Billing Policy and Code of Conduct Policy which is something new (progressive discipline/penalty/repercussions)
