The Fire Board of the Rio Rico Medical and Fire District (RRMFD) met in regular session on Wednesday, September 28, 2022 at 5:30 p.m. The meeting was held at Rio Rico Medical and Fire District administrative office, 822 Pendleton Drive, Rio Rico, AZ.

    - Chief Amezaga presented challenge coins to the Board Members. In the fire service these represent teamwork. George Cluff presented the history of the challenge coins which started with the military.

Dean Davis noted the sign at Station 1 is being worked on and coming along!

### f. Financial Report

- i. Presentation of Financial Reports up to August 31, 2022
  - Presented by Ana Holman
  - Teamed up with Mariposa Community Health Center and will be receiving \$10,000 for the Narcan overdose project Safe Stations (SOS)
  - Training expense two employees taking the paramedic class
  - Employee expense higher than last year due to increases to employees and minimal staffing causing additional overtime. DC Urbanski and Chief Amezaga working on promoting part time to full time.
  - PSPRS Tier 1 & 2 overpayment refunds were processed to their accounts today
  - Financial Audit is in process
  - Extrication equipment has been received (Governor Highway Safety Grant)
  - Board Policy to be reviewed in October
  - Financial Policy to be reviewed in November
  - Possible change to reviews from annually to every two years

- a. Discussion and possible action re: Approval of financial reports for August 2022.
  - Motion to approve financial report for August 2022 made by Brad Beach, second by Dora Urias
  - Motion passed unanimously by verbal vote
- b. Discussion and possible action re: Revising previously approved motion to purchase the audio-video equipment for Station 2 in the amount of \$55,160.35 plus a 10% variance from proceeds of Proposition 207, remainder to come out of the capital reserve account which will be reimbursed upon the next installment of Proposition 207, Smart and Safe to read \$62,391.08 plus a 10% variance from proceeds of Proposition 207,

remainder to come of the capital reserve account which will be reimbursed upon the next installment from Proposition 207, Smart and Safe due to a change in the original order quote

- Chief Amezaga noted the first portion of the paragraph was approved initially; product is no longer available; additional product has a two year wait; switched vendors for equipment and inflation is up causing the additional cost
- Motion to approve the Smart and Safe to read \$62,391.08 plus a 10% variance from procededs of Proposition 207, remainder to come of the capital reserve account which will be reimbursed upon the next installment from Proposition 207, Smart and Safe due to the change in the original order quote made by Dora Urias, second by Brad Beach
- Motion passed unanimously by verbal vote
- c. Discussion and possible action re: Burn Tower Training Facility for Station 2 per proposal
  - Chief Amezaga addressed the board stating he's been looking into; has had meetings with all shifts who agree training is the number one asset for the District; with academies and addition of BC of Training need to update our facility to include a burn facility. City of Nogales has a very small Class A unit and RRMFD has a burn prop trailer which uses propane. Nearest full scale facility would be Tucson Fire or Northwest Fire cost is extremely high, \$5,000 or more for use of facility. Would like to see RRMFD continue to move forward with growing the District which would require Board approval to allow him to pursue this avenue with purchase of facility utilizing the bond capacity (1.6 million available). Timeline would include communication with Mike LaValle of Stifel regarding bond utilization and retention of attorney for paperwork regarding bond. Sight has been approved; some infrastructure will be required; proposed facility would be epicenter of training.
  - Dean Davis questioned applicable taxes; liability and area security, consider fencing area; Brad Beach questioned if we would consider renting the facility.
  - Chief Amezaga noted we probably would not rent the facility; requires certification every five years at an approximate cost of \$2,400; possibly could offer an annual membership to other departments for use of facility (\$2,500) to cover recertification fees and incidentals; tower facility life is 45 + years
  - Motion to allow Chief Amezaga to pursue more information and pricing regarding the burn tower training facility for Station 2 made by Dean Davis, second by Dora Urias
  - Motion passed unanimously by verbal vote
