 - Mark South wrote a Wildland Fire grant to the State, Volunteer Fire Assistance Grant in the amount of \$3,408 – this is a 50/50 matching grant with RRMFD paying half. This is for Wildland PPE

iv. COVID-19 Update

- Four operations personnel were out; all but one has returned
- Moderna Vaccine has arrived. Michael Fielder, Brett Moffit, Chris Ringston, Antonio Sanchez and Paul Sanchez were the first to receive
- COVID transports are on the rise with increased transports to the Phoenix area
- Maintaining 11 personnel on all shifts
- Labor discussion Spoke with Michael Fielder, Union President. Topics included Leader-Ship Development Academy and application process; COVID Vaccine accessibility; reluctance to receive vaccine stemming from science (too quick to approve); don't want to be a guinea pig or have religious beliefs against receiving.

- i. Inspections and Plans
 - ER.com upgraded their security system December 5, 2020
 - NFIRS upload for November pending due to upgrade; also pending 42 COVID 19 results
 - Attended 4 webinar/trainings
 - Burn Permits = 1 permit issued for the Love's Truck Stop area
 - 4 inspections and 1 follow up inspection done
 - Pre-plans on the west frontage road to the north end of the district continued
 - Fire Calls 2 Fires, one a false alarm; alarm system malfunction and alarm activation in error
 - 2018 International Fire Code amendments completed and submitted to the Arizona State Fire Marshal's Office for review and approval

ii. Community Events

- Collected toys and food for local families
- Participated in the Turtle Program sponsored 60 families
- RRMFD collected food and gifts for a local family who lost a loved one and presented them to the family with Santa
- Bike Helmets issued at the Rio Rico Rotary Bike distribution for 72 participants

 - Chief Amezaga committee has met twice to discuss the viability of an IGA with NSFD; several budgets were presented; financially RRMFD could operate and do it; found something that we think can make it work. Next meeting will be to finalize the IGA, with the help of John Flynn, and present to the Board for review with financial info. Hoping to staff 7-9 individuals; turn around by NSFD by the 3rd year with possible annexation and additional opportunities to make the position stronger.
 - Michael Carlson noted there was a great deal of thinking outside the box; making it viable short term; and long term, could be a beneficial opportunity.

- Update by Chief Amezaga: Chief Amezaga and Frank Granados have been working together on the
 details; will be sending out to 3 manufacturers for competitive pricing even though we are still
 looking at teaming up with Green Valley. Good business sense to see if they can compete before
 staying with one vendor. Will not go over budgeted amount of \$440,000

 - Training will take place in January online

 - Michael Carlson nominated Brach Beach as Clerk of the Board. Brad Beach accepted the nomination. Michael Carlson motioned Brad Beach for Clerk of the Board; second by Dora Urias
 - Motion passed unanimously be quorum present
 - Michael Carlson noted the Chairman of the Fire Board is also the Chairman of the PSPRS Board
 unless duty is designated to someone else. Place on agenda for next meeting to confirm Frank
 Bejarano's acceptance or designation for the PSPRS Board Chair
 - Discussion and possible action to approve RRMFD revised 2018 International Fire Code and Amendments
 - Az State Fire Marshal's office has not confirmed approval tabled awaiting approval
