Discussion, review and update re: Amending the NSFD district boundaries to include certain properties within the Kino Springs area and adjacent to the boundaries of the district that have been paying taxes and received the fire protection services but not included on the legal description of the District boundaries pursuant to A.R.S. 48-262 (H).

- c. Discussion, review and possible action re: Consolidating NSFD and RRMFD
 - Chief Amezaga noted past discussions included wording to merge the two districts which is incorrect. Correct wording is consolidation NSFD Board will no longer exist; the RRMFD Board will take over and take over the running of Nogales Suburban which will no longer exist. Merger would involve two boards being combined. Will present to the RRMFD Board at their Board meeting. Wanted to clarify the terminology merger versus consolidation. Also noted there is a vacancy on the RRMFD Board; unknown time element to complete (possibly within 6 months) consolidation but should be very quickly as it is driven by the two Boards with a notice to the public, but ultimately becomes the decision of the two Boards.
 - Motion to move forward with the consolidation of NSFD and RRMFD made by Dora Madrid, second by David Valenzuela
 - Motion passed unanimously by verbal vote
 - Chief Amezaga will report the decision to the RRMFD Board
