 - Currently Medicare/Medicaid providers of service are requiring 75% of personnel be vaccinated.
 - District currently at 78%
 - Discussion amongst those in attendance at the meeting with opinions, concerns and protocol

- No current policy regarding vaccination. Would need to be addressed and created should it be mandated.

 (noted this is the cap of contract) retroactive to April, 2021 and look at financials for NSFD to make sure
 there is sustainability to afford at least \$36,000 a year to provide compensation for the extra workload
 being carried by Chief Amezaga, the Admin Manager, the Deputy Chief, the Fire Marshal and the
 maintenance personnel to be presented to the Board next month. Second by Dora Urias
 - Motion passed unanimously by verbal vote

 - Motion approved unanimously by verbal vote

 - Motion passed unanimously by verbal vote
